The Dubrovnik Seminar is organized by the Jean Monnet Chair of European Public Law, University of Zagreb - Faculty of Law. The event entails two parts - lectures by prominent EU law professors and members of the Court of Justice and research presentations by PhD candidates and junior academics.

This year the seminar deals with the topic of EU law and risk regulation. Organisers welcome researchers interested in presenting a paper dealing with any aspect of risk regulation in the EU whose aim is to minimise risks to public health, safety, data protection, life quality, environment, animal welfare, the functioning of the EU, etc. Candidates are invited to apply by submitting a paper proposal and CV. Accepted candidates will be eligible to publish their papers in the [Croatian Yearbook of European Law & Policy](#). Those interested in participating without a paper are also welcome to apply by submitting a motivation letter and a CV. Due to a limited number of places, those applying without a paper are recommended early registration.

Deadlines

submission of papers by selected candidates: 10 April 2015
submission of papers for publication in CYELP: 1 June 2015
motivation letter and a CV (participation without a paper): on a rolling basis

Grants

All authors of accepted papers will receive grants covering reasonable travel expenses up to 500€ and lodging with breakfast for three nights. There is no need to submit any additional grant applications.

A limited number of grants is available for advanced students and young professionals (participants without paper).

Applicants from non-EU states who want to take part in the conference (without a paper) may be eligible for [IUC grants](#). Such applicants should submit the grant application form and submit it to the IUC directly.
