## OPEN CALL FOR APPLICATIONS Intensive Regional Training of Multipliers for Legal Clinics – Workshop for Students –

### 17 – 19 September 2018

Venue: Belgrade (University of Belgrade Faculty of Law)

Together with the South East European Law School Network (SEELS) and its member faculties as well as the Law Faculty of the University in Banja Luka, the Europa-Institut of Saarland University is implementing a project "Acces2Justice4All: Clinical legal education – Supporting the access to justice in SEE" which deals with the access to legal information and advice by strengthening the clinical legal education at law faculties in the Western Balkans and Germany. In this phase of the project we are announcing an open call for students to attend Intensive Regional Training of Multipliers for Legal Clinics. On this training the students will be trained with skills such as effective case management systems, clinic procedures (acquisition of cases, administration of cases, internal procedures prior to communication with the client, etc.), client interviews, brief writing, legal limits to the provision of legal advice, legal ethics and questions of liability, soft skills (e.g. communication skills), office and project management and fundraising.

The participating students will be explicitly given the opportunity to share experiences in running university-based law clinics as well as to network among each other.

### TERMS OF PARTICIPATION (please read carefully)

**Participation and cancellation**: If your application is selected you will be notified and expected to confirm the participation within 7 working days. Failure to do so will result in withdrawal of the selection. If you confirm the participation you can cancel it latest 4 weeks prior to the event, without statement of the reason. In case of unforeseen circumstances as a reason for cancelation in a period shorter than 4 weeks prior to the event you have to notify the office without any delay with explanation of the reasons. Any other cancelation on short notice or no-show will be reported to your academic institution and the eventually occurred costs should be borne by you. If your application is selected on a waiting list you will be fully informed. Your participation will be available only in case one of the selected applicants cancels their participation. This may result in selection on short notice.

**Travel:** Selected participants coming outside from Belgrade will be responsible for their own travel arrangements. If selected, please start organizing your travel as soon as possible. In case you need help or assistance, feel free to contact us. The costs of the travel will be reimbursed at the end of the Intensive Regional Training of Multipliers for Legal Clinics and will be dependent on regular attendance of lectures.

In case of travel by plane or bus please provide original receipt/invoice. In case of travel by car please inform us about your traveled kilometers since you will be reimbursed with 0,20 Euros per kilometer. Please note, that according to German Funding rules we are not able to reimburse more than 120 Euros when you travel by car.The reimbursement will be in principle in real costs. In case that you have to pay more than 120 Euros, please contact us before you buy your tickets.

Accommodation: Accommodation for participants outside from Belgrade will be provided in standard double rooms in hotel (TBC) in Belgrade. Costs for accommodation and the course are covered by the DAAD with the financial support of the German Federal Foreign Office. Meals will be either provided or financially supported. Additional costs could occur for daily expenses and additional excursions.
