PARTICIPANTS

Prof. Dr. Lena Foljanty holds the professorship for globalisation and legal pluralism at the University of Vienna and is head of the Max Planck Research Group "Translations and Transitions: Legal Practice in 19th Century Japan, China, and the Ottoman Empire". Her main research concerns the history of globalisation, contemporary legal history and the history of legal theory, method and practice.

Prof. dr. sc. Ivan Kosnica is an Associate Professor at the Chair for History of Croatian Law and State at the Faculty of Law, University of Zagreb. His main research interest is history of citizenship in Croatian context and in comparative perspective in the period from 1848 onwards. His researches also include history of citizens' rights and administration from 1848 until 1941.

Prof. dr. sc. Mirela Krešić is an Associate Professor at the Chair for History of Croatian Law and State and Head of the Institute of Legal History and Roman Law at the Faculty of Law, University of Zagreb. Her research interests focus on the Croatian legal history especially in the field of private law (e.g. inheritance law and commercial law), women's legal history and legal history of the Croatian Muslim community.

Doc. dr. sc. Dunja Milotić is an Assistant Professor at the Chair for History of Croatian Law and State at the Faculty of Law, University of Zagreb. Her research interest focus on the history of criminal law, particularly trial by jury in Istria and Dalmatia from 1848 to 1918, and criminal law in the Yugoslav State between the two World Wars, as well as commercial law of the same period.

Dr. Sebastian Spitra holds a post-doc position at the Institute for Legal and Constitutional Law at the University of Vienna. He has completed his LL.M. at the University of Michigan and his focus of research is i.a. on the history of international law, legal protection of cultural heritage and the intellectual history of law.

Dr. Stefan Wedrac holds a post-doc position at the research centre for indexing legal resources at the University of Vienna. Until 2019 he worked as an academic employee of the Austrian Academy of Sciences. His research focus i. a. on the history of the late Habsburg monarchy, the history of health insurances and the history of Italy and the Italians in Austria-Hungary.
